THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI GIRIDHAR GOMANGO): (a) to (d) The needs of Posts and Telecommunications being different it may not be appropriate to com-

pare the physical and financial resources allocated to them. Recognising the need for separate development of these two sectors, Government had established two separate Departments for Posts and Telecommunications by bifurcating the erstwhile combined P & T Department in January, 1985. Posts are basically labour intensive. Telecommunications however, largely technology oriented and require a large measure of capital investment for its development. The allocation of resources is determined by the Planning Commission and the Government taking into account the different needs of the Posts and Telecommunicatons. The Plan allocations during the last three years are as follows.

System to check misuse of STD and ISD Facility

THE MINISTER OF STATE IN THE :M?NISTRY OF COMMUNICATIONS (SHRI GIRIDHAR GOMANGO): (a) and (b) Yes, Sir. An STD/ ISD call control facility has been introduced in some digital electronic exchanges (E-10B) on an experimental basis. Under the system, STD/ ISD calls facility can be activated/ deactivated by subscriber himself by dialling a code chosen and known to him only.

(c) and (d) No, Sir. This is possible only in E-10B exchanges at present.
