## Books containing derogatory remarks on women

3259. SHRI SHIV PRATAP MISH-RA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government's attention has been drawn to a statement of Prof. Ram Reddy, Vice Chancellor of Indira Gandhi National Open University which appeared in the Times of India dated 25th December, 1988 to the effect that 22 English and 20 Hindi language instruction text books prescribed in Haryana, Punjab, Rajasthan, Madhya Pradesh and Delhi contained derogatory references to women; and
- (b) whether Government have ordered an enquiry to find out the circumstances under which such references were allowed in text books and the steps taken to ban such books?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) Yes, Sir.

(b) Prof. Ram Reddy, Vice-Chancellor of the Open University, has made these observations as an academician in his individual capacity. His statement is based on the book by Shri Narendra Nath Kalia the "Sexism in Indian Education—The Lies We Tell Our Children."

Syllabi and text-books for Classes I to XII are prepared at the national level by the NCERT. The States are free to adopt/adopt these books. The States frequently have entirely new books written by their agencies.

In keeping with the National Policy on Education-1986 which emphasises education for women's equality and has included the concept of equality of the sexes in the core curriculum, the NCERT is preparing new textbooks for all the classes from I to XII.
