## Laboratory tests of samples of imported white cement

3568. SHRI BHAGATRAM MANHAR: Will the Ministe, of FINANCE be pleased to state:

- (a) whether it is a fact that sometime in July|August, 1984 the Bombay Customs had sent the samples of imported white cement for laboratory tests in the Central Government Laboratory:
  - (b) if so, what are the findings thereof;
- (c) whether it is also a fact that the test reports confirmed that the imported white cement was found to be in conformity with ISI specifications 269|1976 for ordinary portland cement as regards its physical and chemical composition, and
- (d), if so, what are the details in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJIT PANJA): (a) and (b) Yes, Sir, Sample of imported white cement was tested by the Bombay Custom House Laboratory in July August, 1984, and found to conform to "IS-8042" for white cement.

(c) and (d) The imported white cement was not found to be in conformity with ISI specifications "269-1976" for ordinary portland cement as regards its physical and chemical composition.
