SHRI SATYA PRAKASH MALAVIYA: Political murders are taking place in U. P. and Rajiv Gandhi.... (Interruptions).

THE VICE-CHAIRMAN (SHRI JAGESH DESAI); Mr. Virendra Verma also can speak (Interruptions).

SHRI SATYA PRAKASH MALAVIYA: This is a violation of our rules.

THE MINISTER OF STATE IN THE MINISTRY OF PARIAMEN-TARY AFFAIRS (**SHRI** M. M. -JACOB): Sir, I want *X6* make two or three points in this connection.

First of all, Special Mentions in this House are based on precedents followed here and there is no special rule for a Special Mention. But the precedent is to give it before 10 o'clock, whatever notice you have to give. But there are occasions in this House—and there have been occasions even in this very same session and in the previous session—when Members come with some urgent and important matters, even at ihe time when the Chairman is sitting in the Chair... (Interruptions) ...

SHRI SATYA PRAKASH MALAVIYA: He has refused and he has never allowed ... (Interruptions) ... The Chairman might have been approached. But he has refused... (Interruptions)...

SHRI M. M. JACOB: I am coming to that; I am coming to that only.

So, Sir, the Chairman has the power to allow a Special Mention, even suspending the normal rules, if there is a provision under Rule 267. But, Sir, in this case, there is no rule actually to be suspended also. So, the Chairman has the right to allow a Special Mention at any time

for allotting Special 186

when the Chairman decides to allow it. So, in this case, the Chairman or the Vice-Chairman now occupying the seat, has the right to allow a Special Mention.

ings because I am also exercised. But, Sir, I am only commenting on the submissions made by Mr. Jacob. I do not think that at any time in the past a Special Mention was permitted just by the Chair. Many issues have been raised I know. But I do not think that any Special Mention has been permitted by the Chair on the spot, without giving notice. This is for you. This is for future guidance also. It is for you to consider whether Special Mentions can be allowed without a formal notice being gi'^en.

THE VICE-CHAIRMAN (SHRI JAGESH DESAI): I have heard both the sides, Sometimes if a situation arises in strch manner, then for conducting smooth functioning of the House also we have to make so-v.e kind of adjustment. In the past also even a Special Mention was converted into a full debateTI

SHRI SATYA PRAKASH MALAVIYA): That is a different point.

THE VICE-CHAIRMAN (SHRI JAGESH DESAI): \ And secondly, women Members were so much agitated. Then I thought that it is better that it should be allowed, and from this side also some Members should be allowed. But this should not bt taken as a precedent. But the situn tion was such. Then I thought that I should discuss it with the leaders of the opposition also. I think we came to some conclusion that one will be allowed from this side and one from that side. As such, please allow me to proceed like this. I ask Mrs. Sudhn Joshi to speak.
