"That Dr. (Shrimati) Najma Heptulla be chosen as the Deputy Chairman of the Rajya Sabha."

The motion was adopted.

THE LEADER OF THE HOUSE (SHRI P. डा० श्रीमती नाजमा हेपतुल्ला: बिरयानी तो स्नाप खाते ही है, विकल जी।

SHRI JAGESH DESAI (Maharashtra): Mr. Chairman, Sir, I am very happy that Najmaji has become the Deputy Chairman

[Shri Jagesh Desai] of this House, I know her since the last twenty-five years.

MR. CHAIRMAN: Fifty-five years?

SHRI JAGESH DESAI: I said that I know her for the last twenty-five years.

MR. CHAIRMAN: I thought you said ,'fifty-five'

SHRI PARVATHANENI **UPSUDRA**: Don't increase her age.

SHRI JAGESH DESAI: Sir, we have worked together in Bombay. I have seen her quality. She has a very intelligent and a very tactful attitude.

MR. CHAIRMAN: Attitude? I thought you said 'husband'.

SHRI JAGESH DESAI: She has the ability to solve every problem.

I am also happy for the reason that she is my sister. On every rakhi day, she ties rakhi on my hand. I am very happy therefore, that my sister has become the Deputy Chairman of this House

Sir, on many occasions, tempers run high in the House. I am sure with her smiling face, tempers will cool down and tension will disappear. I wish her success and on behalf of the Panel of Vice-Chairmen, I assure her that we shall give full co-operation to her in conducting the Business of the House.

MR. CHAIRMAN: I join the Leader of the House and Leaders of the various groups and others in offering my warm felicitations to Dr. Najma Heptulla on her election as the Deputy Chairman of this House.

Dr. Najma Heptulla has come back to this seat after nearly three years and is bringing with her rich experience. I have no doubt that she will be able to preside over the deliberations of this House as ably and competently as she did in her last stint. During the period she was not occupying the Chair, she has been an active Member of this House and has been taking keen interest in its functioning. There is, therefore, a sort of continuity. Sinc she has been in touch with the methods and moods of this House, I am quite sure that she will be able to soften the ruffled tempers by her tact and charm. I once again congratulate her and wish her success in office of Deputy Chairman.

DR. (SHRIMATI) NAJMA HEPTUL-LA: Mr. Chairman, Sir, I think perhaps this is the last time-I hope so-that I this is the last time-I hope so-that I thank you the Leader of the House and Members of different political parties and groups and other Members who have words for spoken such complimentary me on this occasion which is given to me by our leader. Prime Minister Gandhi, whom I also thank.

Sir, I have had the privilege of having you guidance since I was in college while I was doing my Phd degree and also when I started my career as a lecturer you were the Minister for Education, Madhya Pradesh. I hope I will have the same support and guidance from you in performing my duties.

Sir, today our Prime Minister is not with us here because he is performing a more pleasant duty of receiving President Gorbachev, Madam Raisa Gorbacheva, the great friends of India and crusaders of peace. Sir, in this House we have discussed disarmament and peace on many an occasion and I was fortunate enough to be presiding in this House in 1985 when we congratulated and passed a resolu. tion on Prime Minister Rajiv Gandhi's efforts for the 6-nation Nuclear Disarmament Conference. The 1986 Summit of President Gorbachev and Prime Minister Rajiv Gandhi led to signing of INF treaty. I hope that 1988 meeting will lead total disarmament and peace and survival for the mankind.

Sir, when I was elected last time it was barely three months after the martyrdom of our most beloved leader, Indira Gandhi and what I had said I would like to quote that the one person I admired, respected any adored was not with us and my happiness was mingled with a touch of sadness. Today again it is the

wish of providence that I have been given this responsibility on the eve of her birthday tomorrow.

Sir, it is also a very significant occasion that our country is celebrating the centenary of our great leader and son of India, Pandit Jawaharlal Nehru, the supporter of democracy, socialism and secularism. I hope, as he upheld the lofty ideals of democracy in our country all his life we would do so in his memory. Sir, we are also celebrating the centenaries of a galaxy of great freedom fighters, like Pandit Govind Ballabh Pant, my grand-uncle, Maulana Abul Kalam Azad and many others.

SHRI SATYA PRAKASH MALAVIYA: Also of Acharya Narendra Dev and Acharya Kriplani.

DR. (SHRIMATI) NAJMA HEPTUL-LA: Yes, Sir, all those freedom fighters whom we know and also those whose names we do not know, who fought under the leadership of Mahatma Gandhi to free this country, who believed in secularism and democracy. I hope we will remember that we have got this freedom after a great struggle and we will protect it to the best of our ability.

Sir, I had crossed this floor before the enactment of the Anti-Defection Bill. Then I was in the Chair when the Bill was enacted. Now I again cross the floor without being affected by this. I think I am perhaps the only privileged person to have been doing this.

Sir, yesterday Mr. Gurupadaswamy said that I should be on his side. Sir, as a Presiding Officer, I certainly cannot take sides, but I assure him that I will be beside him.

Sir, last time the Prime Minister was here when I was elected. He said in his speech that I should spill over the charms that I have to the Members with whom you have brought me to sit. It is a long time — almost four years. I do not know how much charm is left in me...

SHRI M. S. GURUPADASWAMY: Still a lot is there. DR. (SHRIMATI) NAJMA HEPTUL-LA:but whatever is left, I would definitely spill it all over the House.

Sir, Mr. Upendra disclosed a closely guarded secret which happened behind the scenes in the chambers and he said that the 'Biryani' and 'Pheerni' made them go to sleep. But now that he has grown out of it, I will have to think of some other measures.

MR. CHAIRMAN: To make him sleep.

DR. (SHRIMATI) NAJMA HEPTUL-LA: Perhaps if I am not being quoted later on, I would not use the drugs, but may be I will have to use some other methods to keep him quiet.

Sir, I thank, once again, Mr. Gurupadaswamy, all the other Members, especially the Panel Members and Jagesh Desai Ji. Sir, Mr. Shiv Shanker has a very mysterious way of appearing, disappearing and again appearing over here! A few moments ago, when I started, he was there, but I was presenting him compliments in absentia. I thank all of you and hope the sentiments that you have expressed and the confidence that you have reposed in me will make me run the House as efficient-

ly or, perhaps, more efficiently, because we do not run this House only with the help of the Rule Book. I have noticed it and have said it once from the Chair that we run this House with the help and cooperation of all the Members-on the right—on the left and at the centre.

I thank you, Sir once again, for giving me this opportunity of serving with you.
