THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE

(SHRI P R. DAS MUNSHI): (a) and (b) Consequent upon the canalisation of import of edible oils through STC in December, 1978, STC arranged imports on f.o.b. basis and subsequently on C&F basis. Later on, STC had to resort to imports of edible oils on CIF basis due to the nonavailability of adequate cargo space by Indian ships and the necessity of arranging timely imports of essential items of human consumption as per the programme given by the Government.

- (c) STc incurred heavy shortages in receipt of oils imported on f.o.b./ C&F basis and had consequently to revise the purchase terms on CIF basis.
- (d) Government had decided to resume imports of certain edible oils from Malaysia on f.o.b. basis on trial basis. The f.o.b. terms of purchases are being finalised by STC in consultation with the suppliers and Transchart.
- (e) STC has been using available Indian vessels for carriage of oils from Malaysia/Indonesia even against c.i.f. terms of purchases and for transporting oil from Western Coast of India to the Eastern Coast.
- (f) Cost effectiveness and savings of foreign exchange are dependent on timely availability of Indian ships
