THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. R. DAS MUNSHI): Yes. Sir.

- (b) The units in the Zones are permitted, on a case by case basis, to to sell upto 25 per cent of their production in the domestic tariff area, if the indigenous content in the total cost of material inputs is above the level of 30 per cent, and upto 15 per cent, if the indigenous content is less than 30 per cent. Such units can also supply the goods produced by them to the domestic market against valid import licences. In both cases, the prescribed duties would be applicable.
- (c) Government have not taken a decision on the application of the company.
- (d) In regard to Export Processing Zones are 100 per cent Export Oriented Units, foreign collaboration for the production is duly permitted including in the sector of consumer goods.
- (e) The Government's policy is not to encourage the use of foreign brand name on products meant for sale in domestic market. Under the Foreign Exchange Regulation Act, prior permission of the Reserve Bank of India for use of foreign trade marks is required if such use involves direct or indirect consideration.
