Closure of MSK Mills, Gulbarga

2469. SHRI H. HANUMAN THAP-PA: Will the Minister of TEXTILES be pleased to state:

- (a) whether it is a fact that negotiations were held with the workers' representatives of MSK Mills, Gulbarga during the month of September, 1988;
- (b) if so, what were the proposals given to the workers and what was the result of the negotiations, since the Milis is closed and whether it is a lay off or lock out or complete closure; and
- (c) in case it is lay off, whether the workers are entitled to 50 per cent of the wages and whether any wages have been paid to the workers ever since the closure of the Mills?

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI RAFIQUE ALAM): (a) and (b) Yes, Sir. After having further discussions with the trade unions by the management during October, 1988 an interim agreement was signed on 29-10-88 covering the following important points: —

- (1) a long term work-load agreement shall be signed after negotiations and before the re-opening of the mill;
- (2) linking 40 per cent of wages with productivity;
