Accident of 234 Down Churu-Jaipur Train

- (a) whether it is a fact that the 234 Down Churu-Jaipur train rammed into a tractor-trolly at Loharwada railway gate on 15th September 1988 near Jaipur.
- (b) if so, the number of persons who died and those who were injured in the said accident; and
- (c) whether the gate or railway crossing was unmanned?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD) (a) and (b) Yes, Sir. However, this accident took place on 14-9-88. As a result, 10 persons in the tractor trolly died and another 7 sustained injuries.

(a) whether it is a fact that the target set for National Highways in Road Development Plan for Gujarat has not been achieved till this day;

- (b) by when the said target is likely to be achieved;
- (c) whether the National Transport Policy Committee has recommended to upgrade three roads as National Highways in Gujarat;
- (d) whether the Gujarat Government has also requested the Ministry of Surface Transport to declare some roads as National Highways;
- (e) if so, what are the roads which have been suggested by Gujarat Government to be declared as National Highways; and
- (f) what action has been taken by Government in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) and (b) Presumably, the Hon'ble Member is referring to the 20-Year Road Development Plan (1981—2001) which aims at a balanced de-

velopment of the various category of roads including National Highways as a whole in the country. The targets enunicated in the Plan are only recommendatory in nature. Even otherwise, it is too early to indicate the feasibility of achieving the targets set forth in the development Plan at this stage.

(c) Yes, Sir.

(d) to (f) A statement indicating the proposals furnished by the Gujarat Government after 31st March, 1985 is attached. (See below). So far the Ahmedabad-Vadodara Road segment in Gujarat has been included in the National Highways network with a view to develop it as a Expressway at an estimated cost of Rs. 128.4 crores. There is, however, no possibility to make further expansion of National Highways in the State owing to paucity of funds under the central sector roads programme in the current Plan period.
