Cut in Allocation of Funds for Education

- 71. SHRID. B. CHANDRE GOWDA. Will the Minister of HUMAN RESOUR CE DEVELOPMENT be pleased to state:
- (a) whether Government's attention, has been drawn to a news item in the Times of India' dated the 17th September, 1988 under the caption "Fun shortage hits education plans";
- (b) if so, whether due to drastic cut in allocations made for implementation of the new education policy, the plans are in doldrums; and
- (c) if so what are the reasons for drastic cuts in allocations and what steps Government propose to take to provide adequate funds?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) Yes, Sir.

- (b) There is a resource constraint. Notwithstanding the overall constraint how. ever, efforts are being made to implement the thrust areas under NPE as best as possible.
- (c) The resources made available for education depend upon the total availability of resources for developmental activities and the competing demands from other sectors.

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT); (a) The total length of National Highways is 32138 km. The following amount was sanctioned for maintenance of National Highways during the last three years.
