Increase in flight frequency of Indian Airlines

*16. SHRI M. VINCENT: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to refer to answer to Starred Question 424 given in the Rajya Sabha on the 31st August, 1988 and state:

- (a) what has been the percentage of increase in passenger traffic increase in flight frequency and new extensions of flights by the Indian Airlines during last three years;
- (b) what is the name of the State which had the maximum flight frequency added and extensions of flights added during the ast three years; and

(c) whether considering the increase in the traffic, the Airlines have added more aircraft in their fleet?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL): (a) During the years 1985-86, 1986-87 and 1987-88, the percentage increase in passenger traffic of Indian Airlines was 7.3, 8.2 and 5.7, respectively. During this period, Indian Airlines added three new stations viz, Car Nicobar Singapore and Calicut to its network. A statement showing increase in frequencies and route changes of Indian Airlines flights is laid on the Table of the Sabha (Se_e below).
