AIR Broadcast Service for USA and Canada

2799. SHRI SHIV PRATAP MISH-RA: Will the Minister of INFORMA-TION AND BROADCASTING be pleased to state:

- (a) whether it is a fact that a large Indian community lives in USA and Canada;
- (b) whether Government propose to start AIR Broadcast service to these two countries; and
- (c) if so, by when and if not, the reasons therefor?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF INFORMATION AND BROAD-CASTING (SHRI H. K. L. BHAGAT):

(a) Yes, Sir.

(b) and (c) Owing to limited hardware capabilities and the imperative need to make optimum utilisation of the existing transmitters for services which are accorded higher priority, there is no proposal to start All India Radio Broadcast Service to these two countries. However, All India Radio is sending canned programmes to the ethnic stations and some broadcasting organisations of USA and Canada, especially for the benefit of the Indian community there.
