The Comprehensive Crop Insurance Scheme (CCIS) already provides that the unit area of crop insurance may be a district/tehsil/taluka|block or other smaller contiguous area subject to the condition that the State Government has the yield data for last three years for wheat and paddy and for last 5 years for millets, oilseeds and pulses for the concerned unit area and it is possible to conduct atleast 16 crop cutting experiments in each of this area for each of the crop covered under the CCIS at the end of every season.

As regards covering the non.loanee farmers under the CCIS, there is no proposal to extend the CCIS to the non-loanee farmers.
