- (c) whether it is a fact that BICP also confirmed this position; and
- (d) if so, what steps have seen taken by Government to correct the under estimation?

Promotion quota in the Department of Telecommunications

- (a) whether the Department of Telecommunications is aware of the Order dated 7th February, 1986 regarding holding of DPC meetings and resorting to direct recruitment in Government services strictly according to the prescribed quota as provided in the respective recruitment rules;
- (b) if so, whether the principal laid down in the above order is being implemented in case of recruitment of its group 'A' employees;
- (c) whether the Department of Telecommunications has already recruited/ initiated action for recruitment from outside against the vacancies for the years 1986, 1987 and 1988 and whereas the quota for the promotees is yet to be filled up through DPC; and
- (d) if so, how the Department propose to fill up the promotion quota and whether any time schedule for holding meetings of DPCs has been formulated?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI GIRIDHAR GOMANGO): (a) Yes, Sir. The Department of Telecommunications is holding DPC for promotion in accordance with the recruitment rules and the direct recruitment is also made strictly in accordance with the prescribed quota as provided in the recruitment rules and in confirmity with the order dated 7th February, 1986.

- (b) The recruitment to Indian Telecommmunication Service Group 'A' post is made strictly in accordance with the order quoted above.
- (c) and (d) The action for outside revruitment against the vacancies for the year 1986, 1987 and 1988 has already been initiated and the DPC for promotion against 1986 vacancies has been held.

A proposal for holding a review DPC for promotion from TES Group 'B' to ITS Group 'A' has also been sent to the Union Public Service Commission in June, 1988. The proposal for holding DPC for the vacancies of 1987 and 1988 being processed and on receipt of the minutes of the Review DPC from Union Public Service Commission, the proposal for holding DPC for promotion for the year 1987 and 1988 will be sent to the Union Public Service Commission.

Setting up of wind based pumping system in AP

THE MINISTER OF ENERGY (SHRI VASANT SATHE): (a) and (b) The Department of Non-conventional Energy Sources has installed 248 windpumps in Andhra Pradesh under the National Windpump demonstration programme. 150 windpumps are under installation at different locations. Recently a field trial project for deepwell windpumping systems, particularly for drought-prone areas, has also been taken up in the State.
