### **Educational backwardness among minorities**

†\*263. SHRI PYARELAL KHANDELWAL: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that one of the main reasons of educational backwardness of minorities, especially of the muslim community is also the unscientific education system of madarsas;

(b) whether it is also a fact that Maulana Azad Foundation established to fulfil the above purpose has also remained unsuccessful in its objective;

(c) if so, whether Government would consider to adopt modern scientific method in madarsas and minority institutions;

(d) if not, the details thereof; and

(e) the State-wise details of such madarsas in the country which receive grant and the manner of Government's control over them?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (e) No, Sir, madarsas mainly impart religious education. The madarsas which volunteer for-introducing modern subjects like Mathematics, Science and English are being assisted under the Centrally Sponsored Scheme of Area Intensive and madarsa Modernisation Programme. A total number of 1631 madarsas have been provided financial assistance under the said Centrally sponsored scheme during 2005-06 for
