Railway Line from Rajgrih to Bodhguya

Survey for Rajgrih-Gaya new rail line was conducted and the project was bound to be financially unremii-nerative.

As regards doubling of Patna-Gaya rail line, a survery was carried out to assess works required to improve line capacity on this section. According to

the recommendatios made in the Survey Report, the following works, costing about Rs. 6.35 crores, have been included in the Budget for 1988-89, foi-augmentation of sectional capacity:—

- (i) Tokenless block working.
- (ii) Conversion of Potahi halt into crossing station.
- (iii) Additional platform at Jehanabad.

Election of Chief of Archery Association of India

Removal of vendor's fro m Railway land at Jogban; Railway Station

the past fifteen years, near Jogbani Railway station on N F. Railway, were forcibly removed in June 1988;

- (c) whether the Divisional Manager (C), N.F. Railway, Katihar had given licences to a large number of these vendors;
- (d) whether D'visional Manager had previously obtained orders from local-Magisterial authorities to evict these landlords;

- (f) what are the reasons for not utilising the Rail-way Protection Force in this operation?

Committee to review air safety measures

- 3231. SHRI V. NARAYANASAMY: Will- the Minister of CIVIL AVIATION AND TOURISM be pleased to state:
- (a) whether Government are reviewing the air safety measures by appointing a Committee of experts, in viewi of the recent aircraft crashes a-Ahmedabad and Guwahati; and
- (b) if so, by when the said Committee would be appointed and by when it would submit its report?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL) (a) and (b) Two Courts of Inquiry headed by High Court Judges have been appointed to investigate into the two fatal accidents which occured at Ahmedabad and GuwaJjati on 19.10.88. These courts, apart from finding out the causes of accidents, normally also make recommendations for bringing about improvements in safety measures if any shortcomings are found during the course of investigation. The Government is appointing a Committee of experts, separately, to review maintenance and training aspects in airlines.
