THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND TOURISM (SHRI SHIVRAJ PATIL): (a) and (b) During the period 1984 to 1988, 73 airhosteeses of Indian Airlines and 464 airhostesses of Air India appeared for medical examination on attaining the age of 35 years. The services of none of the airhostesses were discontinued after medical examination.

(c) Does not arise.

(d) In accordance with the Regulations of Indian Airlines and Air India, Airhostesses retire on attaining the age of 35 years. The competent authority may, however, extend the services of Airhostesses beyond the age of 35 years by a year at a time subject to the condition that the person concerned is medically fit.

(a) An amount of Rs. 9693.71 crores was spent on Education in the entire country during 1987-88 by the Central Government as well as State Governments.

- (b) The percentages of expenditure on Primary Education, Secondary Education, Higher Education and Technical Education were 43.94, 31, 39; 13.52 and 5.16 respectively.
- (c) NPE 1986 gives priority to Primary Education with a view achieving the goal of universalisation of Elementary Education. The scheme of Operation Blackboard is implemented in various States UTs in a phased manner with a view to improve primary school education. The drive is phased to cover 20 per cent Community | Development Municipal areas in 1987-88, 30 cent in 1988-89 and 50 per cent 1989-90. The expanded and reorganised scheme of Non-Formal Education is in operation for those children who have either dropped out of school or cannot attend the forma1 school Teachers Training Institutes being upgraded through the scheme of opening DIETs CTE IASE.
