(fc) No, Sir.

(d) During 1987-88, Air India have not retired any air-hostess from the service On account of superannuation medical examination after the age of 35 years.

Termination of the London based European Air Hostesses

- (a) whether the Air India management has recently terminated the services of six London based European air-hostesses;
