THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIA-TION AND TOURISM (SHRI SHIV-RAJ PATIL): (a) to (e) A_S one of measures of improvement of service, the management decided to enage consultants to advise on continental cuisine. For this purpose, proposals from Ecole Hoteliere Lausanne Institute for Tourism and Hotel Management, Salzburg and also M/s. Steigenberger were considered. On the basis of their long experience in airline catering, M/s. Steigenberger were given the contract as consultants. Engaging Indian consultanc_v serv ces on continental cuisine was not considered appropriate.

New Developments in South Africa

3219. DR. BAPU KALDATE: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government have taken note of new disturbing developments in South Africa; and
- (b) what is Government's reaction to the new restrictions on political opposition announced by the South African Government?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) and (b) The South African Government has banned the activities of 17 opposition groups. Strict press censorship remains in force. Under the continuing emergency the authorities have intensified their repression of the non-white majority. Government have consistently condemned these actions by the racist regime and have actively sought to mobilise world public opinion to bring pressure to bear on the regime with a view to dismantling apartheid and estabilishdemocratic polity based on ing a majority rule.
