## Arms supply to Nepal by China

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) Government have no confirmation of reports to this effect.

(b) Government have on several occasions expressed to the Government of Nepal its concerns at the acquisition of arms by Nepal without apparent reason. Government hopes the Nepalese Government will bear these in mind.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD); (a) Yes, Sir. The Close Circuit Televisions at some of the railway stations are being installed and maintained by private entrepreneurs at their cost on the conditions laid dow<sub>n</sub> by the Railway Administrations.

(b) The CCTV System is already in operation at 41 railway stations. Such a system is likely to be installed at another 17 stations in near future, for which tenders  $ar_e$  being finalised.

(c)  $Th_e$  rates for commercial advertisement spots on CCTV at stations are fixed by  $th_e$  Agencies operating the system.
