DUTIES OF THE LABORATORY ASSISTANTS

1. Upkeep, maintenance and general care cleaning etc. of the laboratory and appliances.
2. Maintenance of stock, issue and breakage registers.
3. Maintenance of botanical gardens, froggery, museum, display material etc.
4. Making local purchases, collection of life/dead specimen.
5. Preparation of charts, per herbarium, models etc.
6. Helping teachers to set up apparatuses/prepare solutions/materials and guide laboratory work under the guidance of the teachers.
7. Check up assignment work of students allotted by the teachers.
8. Prepare indents for purchase of equipments and completing comparative statements.
