Modernisation of Jaipur Airport

699. SHRI SANTOSH BAGRODIA:
Will the Minister of CIVIL AVIATION

(a) whether Jaipur Airport is to be equipped with the sophisticated navigational equipments as a part of its modernisation plan;

(b) if so, what are the details of the plan; and

(c) by when it would be taken up and completed

THE MINISTER OF STATE OF THE

TOURISM (SHRI SHIVRAJ PATIL):
(a) Yes, Sir

(b) and (c) The airport at Jaipur is proposed to be equipped with Instrument Landing System (ILS) and modern visual ground aids. The work of installation of

different components of ILS is in progress. It is expected that the work will be completed in about 3 months. The schemes of conversion of Medium Intensity Runway Lights (MIRL) into High Intensity Runway Lights (HIRL) and 2-Bar AVASIS into 3-Bar AVASIS have been sanctioned. These are expected to be completed in about a year after commencement of the work. Besides, orders have also been placed for procurement of Non Directional Beacon (NDB) and Distance Measuring Equipment (DME) to replace the existing ones; these are expected to be installed and commissioned in about 12 months.

Assault on the teachers of Kendriya Vidyalaya Barrackpore

SHAHI): (a) to (c) As reported by Assistant Commissioner, Kendriya Vidyalaya Sangathan, Calcutta Region, there was a scuffle between two groups of the teachers of Kendriya Vidyalaya, AFS Barrackpore on 23-4-1988 after school hours. A preliminary enquiry into the aforesaid incident was conducted by the officers of Kendriya Vidyalaya Sangathan, Calcutta which revealed that there are two groups in the Vidyalaya and their differences on certain issues resulted into the said scuffle. Both the parties have lodged F.I.R.s in the local police station.
