Till: MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI P. SHIV SHANKER): (a) An amount of Rs. 35 lakhs has been released to Andhra Pradesh in the current financial year as the first instalment. Moreover, sanction has also been issued to permit the State Government to carry forward the unspent balance of Rs. 14.33,380 remaining with them out of the grant released during 1987-88.

(b) 26 projects of 300 centres each have been set up under the said scheme in Andhra Pradesh.

(c) 232,694 learners were enrolled under Rural Functional Literacy Projects during the first quarter of 1988.

(d) The percentages of women and Scheduled Castes and Scheduled Tribes enrolled during the period was 45.8, 30.6 and 15.6 respectively.
