SHRI L. NARSINGH NAIK:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether the Rajendra Kumari Bajpai Committee, (CABE Committee), formed to review and advise on matters relating to educational programmes for SC and ST at the national level, has since submitted its report; and

(b) if so, what are the details thereof regarding the existing arrangements, programmes, schemes, etc. meant for the educational development of the tribal people, particularly in Andhra Pradesh?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) and (b) No Sir. The question of submitting a report does not arise as it is one of the Seven Committees of the Central Advisory Board of Education (CABE) set up for guiding and monitoring on an on-going basis, the implementation of all educational programmes for Scheduled Castes/Scheduled Tribes and other educationally deprived groups, in all States including Andhra Pradesh, as envisaged in the National Policy on Education 1986.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI

MAHABIR PRASAD): (a) Passenger trains on Bibinagar-Nalgonda section have been running since 1981 onwards. In November, 1988 Time Table, Nalgonda-Miryalguda section has been opened for passenger traffic.

(b) Miryalguda-Nadikudi section is likely to be opened for passenger traffic sometime next year.
