## Converting Madras to Gotty Road as National Highway

- 630. PROF. C. LAKSHMANNA: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) whether there is any proposal pending with the Union Government to convert the State highway from Madras to Gotty through Archanam-Ranigunta as National Highway:
- (b) if so, what is the basis for this proposal:
- (c) by when this proposal is likely to be implemented; and
- (d) whether Government have considered the proposal to connect Gotty with Uravakonda in extension of the said proposal so as to connect the highway connecting Madras and Bombay which passes through Uravakonda?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) and (b) Requests have been received for the declaration of this road as a National Highway to cater to the needs of pilgrims and goods traffic, etc.

- (c) Due to constraint of resources it is not possible to declare the road as a National Highway at present.
- (d) Does not arise in view of reply to (c) above.
