

**Penalty clause in the Pepsi Co agreement**

1145. SHRI SHANKER SINH VAGHELA: Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state the text of the penalty clause in the agreement, if the import-export ratio envisaged in the Pepsi Project is not fulfilled by the Pepsi?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI JAGDISH TYTLER):

The agreement has not yet been executed as on date.

**Coverage given by A.I.R. and Doordarshan to President and Prime Minister**

1146. SHRI PRAMOD MAHAJAN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) the total time given to President and Prime Minister on Radio and Doordarshan when both of them were on foreign tour during the last three years; and

(b) the details of the daily coverage about the first priority given to them?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF INFORMATION AND BROADCASTING (SHRI H. K. L. BHAGAT): (a) and (b) The information regarding total time given by AU India Radio [Doordarshan to President and Prime Minister while covering their foreign tours is not kept centrally in a compiled form.

The foreign tours of both the President and the Prime Minister are adequately covered by Ali India Radio and Doordarshan and priority in the news bulletins is given strictly on the basis of news-worthiness of the item.

**A.I.R. stations in Andhra Pradesh**

(a) whether Government have finalised any proposal to set up new A.I.R. stations in Andhra Pradesh;

(e) what are the financial implications thereof, if any?
