MINISTRY OF INDUSTRY (SHRI M. ARUNACHALAM): (a) Yes Sir. According to the provisions of Section 303(2,) of the Companies Act, 1956, every limited company has to intimate any change among its directors within thirty days to the Registrar of Companies;

- (c) No proposal regarding the take over as contemplated under Section 23(4) of the MRTP Act, 1969, of M/s. Larsen and Toubro Limited has been received by the Government.

Development of coal resources

- 1214. SHRI BAIKUNTHNATH SAHU: Will the Minister of ENERGY be pleased to state:
- (a) whether Government are taking steps for the development of coal resources in the country;
- (b) if so, the specific steps taken in the Seventh Plan for the development of coal resources in Orissa; and
- (o) the names of the coal mines in Orissa where steps have been taken in that regard?

THE MINISTER OP STATE IN THE DEPARTMENT OP COAL IN THE MINISTRY OF ENERGY (SHRI C. K. JAFFAR SHARIEF): (a) to (c) Yes, Sir. At present the coal production in Orissa is 8.96 m.t. (1987-88). The production is expected to increase to about 12 m.t. by 1989-90. This production will be achieved from existing mines, reorganisation of mines ongoing projects and new projects.

Some of the major coal projects which have been planned in the -valley and Talcher area of Orissa are: Ananta OC, Kalinga OCP, Lingaraj OC, Samleshwari OCP, Lakhanpur OCP etc. These projects are expected to contribute to increasing production in the Eighth and Ninth Plans.
