## Demand of Gujarat Government for reducing the issue price of gas

1248. SHRI RAMSINH RATHWA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that Gujarat Government has recently demanded reduction in issue price of natural gas to the industrial and other consumers of Natural gas in that State;
- what are the details (b) if so. thereof and what are the basis for such demand as explained by the State Government:
- (c) whether it is also a fact that due to this reason coal consumers of Gujarat have to pay a higher price of coal than the coal producing States as well as the neighbouring States of coal producing States; and
- (d) if so, why Central Government are not rationalising the issue price of Natural gas to the Natural Gas consumers of Gujarat?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND (SHRI NATURAL GAS BRAHM DUTT): (a) and (b) The Government of Gujarat have made certain suggestions for changing the principles on which natural gas prices should be fixed.

(c) and (d) Coal prices are fixed on pit head basis and other expenses including royalty, cess, State tax and transportation charges are in addition to the pit head prices and have to be borne by the consumers. The delicered cost of the coal includes transportation costs which vary according to distances. The delivered cost of gas along the HBI pipelin<sub>e</sub> ha<sub>s</sub> kept uniform after taking into ascount the cost of the pipeline transportation system as a whole.
