Will the Minister of INDUSTRY be pleased to state:

- (a) whether Central Government have since taken any decision on the West Bengal State Government's proposal for the Haldia Petrochemicals Project; and
 - (b) if so, what are the details there. of?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) and (b) As far as the Ministry of Industry is concerned, necessary approvals for the project including extension in the validity of the letter of intent and in the foreign collaboration approvals have been given from time to time.

The Industrial Development Bank of India (IDBI) has reported that financial institutions have not so far cleared the project of M]s. Haldia Petrochemicals Ltd. IDBi ha_s als₀ not received any projections relating to the project from the Company.

- (b) Three wells viz. Cochin I, Kasargad-I and Cochin Higb-I have been drilled so far and all of these proved t₀ be dry.
- (c) Drilling of one well *viz*. CH-2-1 has been planned, Additional seismic data acquisition has also been planned.

Development of mu.tigrade engine oil

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SBRAHM DUTT): (a) to (c)'. Indian Oil Corporation Ltd. (R&D) has developed a multigrade engine oil which is presently under extensive trials by the Railways. Its commercial production will depend on the requirement of the Railways that may be assessed after successful completion of these trials by early 1989. Their present consumption of monograde diesel oils is around 30,000 tonnes per annum

The information regarding 10,559 companies registered during January. June, 1988 is contained in "Company News & Notes" for the months of April, 1988 to October, 1988. Similar information for the months of July-September, 1988 will be published in the subsequent issues of the journal.

However, Governmen' have already placed import of certair categories of bus and truck tyres under OGL at reduced rate of duty in to keep a check on prices of suel tyres.
