LPG Agencies to SCs/STs/OBCs and Minorities in Bihar

† 1637. SHRIMATI KUM KUM RAI: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the number of LPG agencies sanctioned and distributed in rural and urban areas in Bihar during last three years;
- (b) the number of agencies allocated to persons belonging to SC/ ST/Backward Classes and minorities out of the sanctioned LPG agencies mentioned above; and
- (c) the details of rules followed by Government in allocation of LPG agencies?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI E. PONNUSWAMY): (a) During the last 3 years (1997-98, 1998-99 and 1999-2000), 30 LPG distributorships were allotted in different areas of Bihar.

(b) Out of the above number, 10 LPG distributorships were allotted to persons belonging to the Scheduled Castes and 4 to persons belonging to the Scheduled Tribes. There is no reservation for Other Backward Classes and minorities in the allotment of dealership/distributorships of petroleum products.

(c) Under the existing policy, the following reservation has been provided in the allotment of Retail Outlet dealerships, SKO-LDO dealerships and LPG distributorships:—
