sale of Trimethoprim and Sulphamethaxazole in open market

SHRI DAYANAND SAHAY:

Will the Ministry of INDUSTRY be pleased to state:

- (a) whether it is a fact that Trimethoprilum and Sulphamethaxazole are being sold in the open market at much lower prices than the notified prices;
- (b) whether his Ministry verified the purchase prices before revising the formulation prices based on these drugs under DPCO, 1987;
- (c) if so, what is the purchase price of each and what is the notified price; and
- (d) whether it is a fact that 8 per cent incidental has been allowed on notified prices of bulk drugs while fixing formulation prices?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) The current market prices of bulk drugs referred to in the question are not available. The prices of drugs in the open market keep fluctuating like these of other commodities.

(b) to (d) The leader prices of Sulphamethoxazole and Trimethoprim formulations were revised by allowing 8 per cent incidentals over the notified prices of bulk drugs which is a general practice in case of formulations containing price controlled bulk drugs.
