THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) CBSE introduces new elective subjects in the higher secondary stage from time to time based on the felt need of the students and the society.

- (b) and (c) CBSE has proposed to introduce the following three new subjects as electives at the higher secondary stage:—
 - (i) Creative Writing and Translation Studies
 - (ii) Human Rights and Gender Studies
 - (iii) Heritage Crafts

CBSE has planned to inform the schools about introduction of these subjects as soon as the text books are ready.

(d) It would be for the schools opting for the new courses to make available suitable teachers to teach the new subjects.
