

AND SPACE (SHRI K. R. NARAYANAN); (a) and (b) The news item has been seen. Minor gravitational anomaly exists in most of the launch sites in the world including Sri-harikota. The magnitude of gravitation force anomalies which is one-twenty-thousandth of a 'g' is negligibly small to affect the rocket trajectories which are designed to take off against the full gravitational force and reach a velocity of over 7.5 km/second. Such an anomaly can at best affect the final velocity by 1 metre/second, in the value of 7.5 km/second. There is no question of ASLV flights failing due to the minor gravitational anomalies at Sriharikota.

**Crash on AN-32 aircraft near Kanpur**

(a) whether an AN-32 aircraft of Air Research Centre crashed recently near Shivrajpur in Kanpur district killing all the occupants;

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI CHINTAMANI PANIGRAHI): (a) and (b) An AN-32 aircraft, on a routine flight from Agra to Bhubaneswar, crashed about 21 nautical miles north of Kanpur on 4-11-88 at approximately 1525 hrs.
