- (b) if so, what new technology is being brought by pepsico in the manufacture of fruit juice of Potato chips and other snacks and synthetic drinks concentrates; and
- (2) which of the items of manufacture are not already being made and which of the items being made are of poor quality and whether Government have asked the manufacturers to improve their quality?

## THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING IN DUSTRIES (SHRI JAGDISH TYTLER): (a) Yes, Sir.

- (b) Pepsico is one of world's largest food and beverage companies which has developed expertise in food processing packaging and marketing. The proposed icint venture will have access to use of Pepsico's technological resources including plant/system design, layout services without payment of royalties as also its vast international marketing set up.
- (c) Although a number of similar food items are manufactured in India, quality and cost are not internationally competitive as evidenced from the fact that our exports in this area are minimal. It is not the policy of Government to allow import of technology only in respect of items not manufactured in India but such import of technology can be considered where it will result in improving the quality, reduction in cost, creation of better export market etc. It is the constant endeavour of Government to help manufacturers in improving their quality through various policy measures.

## Use of Foreign Tunes by Doordarshan

THE MINISTER OF PARLIAMENTA-RY AFFAIRS AND MINISTER OF IN-FORMATION AND BROADCASTING (SHRI H.K.L. BHAGAT): (a) to (c) No, Sir. Signature tunes are used by Doordarshan for different types of programme, depending upon nature of the programme. For National News Buillerins, the signauture tune is a mixture of Indian and Western music whereas for 'Saptahiki', the music used is Indian. However, as far as possible, Doordarshan gives priority to Indian music in selection of signature tunes.
