### New airport at Ludhiana

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): (a) There is proposal for construction of a Civil Enclave at Halwara Defence Airfield near Ludhiana in the State of Punjab.

(b) The project, *inter-alia* includes construction of a terminal building, civil apron, strengthening of runway, installation of ground lightings, installation of communication equipments, construction of cargo and extension of runway etc.

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): Earlier, the site identified at Chakan in Pune was not acceptable to Ministry of Defence from operational point of view with reference to existing Defence airfield at Lohengaon in Pune. In the month of October 2006, a team comprising officials from Airports Authority of India (AAI), Directorate General of Civil Aviation (DGCA) and Maharashtra Industrial Development Corporation (MIDC) carried out preliminary site inspection of an alternate site near Rajguru Nagar, 6 K.M. north of the initially proposed site at Chakan. This site is acceptable to the Ministry of Defence.

MIDC has been requested to provide the meteorological data of the new site in coordination with Indian meteorological Department. After receipt of these details, a technical study will be carried out and thereafter appropriate decision will be taken by the Government in the matter.

## Introduction of airbus service in North East

2115 SHRI MATILAL SARKAR: Will the Minister of CIVIL AVIATION be pleased to state:

(a) whether it is a fact that the Indian Airlines cannot maintain its schedule for want of sufficient number of aircrafts and pilots;

(b) what steps are being taken to overcome this problem;

(c) whether the services of airbuses will be increased in the North East; and

(d) if so, the details of the programme?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): (a) and (b) The schedule of Indian Airlines is drawn based on aircraft and crew availability, market forces like demand and supply and capacity deployment by the competitors, seasonality, route dispersal guidelines of Directorate General of Civil Aviation (DGCA), other operational constraints and its commercial viability. However, changes in the schedule of operations are sometimes necessitated due to availability of resources on a particular day. Indian Airlines has sufficient number of pilots to cater to the present schedule requirement. Additional aircraft are being inducted for introducing/increasing operations.
