 -Will the Minister of INDUSTRY be pleased to state:
 - (a) what is the quantity of each of the bulk drugs involved on which the amount has been assessed against Cyanamid along with the name of bulk drug and at what rate the amount has been recovered;
 - (b) what are the details of formulations based on each of the bulk drug and what is the amount that has been assessed on each of the formulations;
 - (c) what are the packs and strengths of each formulations involved and what was the quantity of each taken along with the rate at which the amount has been assessed;
- (d) whether it is a fact that the company represented against the assessment;
- (e) if so, what are the contents of the representation and what action has been taken;
- (f) whether any other company also submitted any representation; and
 - (g) if so, what are the details thereof?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) to (g) The required details in the question are quite voluminous. The time & efforts required for collection of these details will not be commensurate with the results likely to be achieved. However the representations made by the company were taken into account by the special team before finalising the report.
