(b) The installed capacity of three units is 200 MW each and that of the fourth unit is 500 MW. The average Plant Load Factor of the units under commercial operation was 77.2 per cent during the year 1987-88.

## Contract with Danish firm

(b) M/s. ITI Ltd., jointly with M/s. HCL has signed an agreement with M/s. NKT, Denmark for transfer of technology on manufacture of Fibre Optic Thermal equipment and manufacture of Fibre Cables, respectively. The Agreement was signed on 6:h May, 1987. The capacity to be set up by M/s. ITI Ltd., is 610 terminals involving capital investment of Rs. 406.41 lakhs which is inclusive of capital goods documentation, know-how and technical assistance.

The project has been approved for implementation with Japanese assistance.
