

(b) As soon as the bottling plant at Tikrikalan becomes fully operational, the plant at Shakurbasti will be closed.

(c) Two new bottling plants are coming up, one at Asauti and one at Tikrikalan, which will adequately meet the current and future requirements of Delhi.

(d) The first unit at Tikrikalan is fully operational. The remaining two units are expected to be commissioned next year.

Norms for the establishment of petrol pumps/diesel pumps and kerosene depots

1984. SHRI BAIKUNTHA NATH SAHU: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) what are the norms fixed for the establishment of petrol pumps/diesel pumps and kerosene depots;

(b) how many petrol pumps/diesel pumps and kerosene depots have been opened in Orissa according to the prescribed norms and what is the location thereof;

(c) whether Government have a proposal to open some petrol pumps/diesel

pumps and kerosene depots in Keonjhar district Orissa; and

(d) if so, details of the new locations?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI BRAHM DUTT): (a) The Oil Industry conducts surveys on a continuous basis and identifies locations which offer adequate potential and also satisfy the volume distance norms evolved by the Oil Industry, for setting up of MS|HSD Retail Outlets under its Annual Marketing Plans. As regards Kerosene agencies these are being set up at places where potential for a minimum sale of 75 Kls. per month is established.

(b) Since the introduction of the above norms|annual Marketing Plans from 1980-81, the Oil Industry has commissioned 64 Retail Outlets (MS|HSD) dealerships and 16 SKO|LDO agencies in Orissa. The details are given in the enclosed Statement (See below).

(c) and (d) IOC has proposed to develop a retail outlet (MS|HSD) dealership at Keonjhar NH|SH-6 in Keonjhar district of Orissa. For the present, no SKO-KDO agency has been planned to be set up in that District.
