The Federal Aviation Administration A rworthiness Directives and M/s. Boeing's instructions are applicable to Boeing 737 aircraft with line Nos. 001 through 464 and a total of 12 Boeing 737 aircraft of Indian Airlines are invo ved. Inspections as stipulated have been complied with by Indian Airlines and no defects have been observed.

Change in the Site of D.T.C. Terminal

2362. SHRI N. RAJANGAM: Will the Minister of SURFACE TRANS-PORT be pleased to state:

- (a) whether it is a fact that the D.T.C. authorities have changed the terminal at Gate II-A, New Delhi Railway Station to Minto Road Terminal;

THE MINISTER OF STATE M'NISTRY OF SURFACE THE TRANSPORT (SHRI RAJESH PILOT); (a) to (d) Keeping in view the over-crowding and other road safety and traffic problems, the Bus terminal had to be changed from Gate-II to Minto Road Terminal, as per advice of the Delhi Traffic Police and Railway authorities. This arrangement is considered more safe for the public. In view of these considerations and also the fact that all the five terminals in the vicinity within a walking distance, no change is contemplated.

Strategies to Promote Literacy

different strategies and methodology to promote literacy in the country;

- (b) whether a meeting of the UNESCO working group on International Year was held in India in October this year; and
- (c) if so, what were the main decisions arrived at and what new strategies are being undertaken in our country to promote literacy?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI) (a) and (b) Yes, Sir.

(c) A Plan of Action was developed by the Working Group according to the following frame-work (i) Issues, (ii) Areas of Action, (iii) Modes of Operation and (iv) Resources. Issues that were identified included the close interdependency of the Unversalisation of primary education eradication of illiteracy, the various factors which contributed to the prevalence of illiteracy, need for the better appreciation of the problems of the disadvantaged sections of the society and the crucial factors which will be strengthening the literacy programmes and making it successfull. Thereafter the specific areas of action were listed out which included drawing up a National Policy, perspective plan of action, mobilisation of resources, environment building strengthening the academic and technical resource support for the programme, stress on involvement of NGOs and designing a suitable mechanism for monitoring and evaluation. The modes of operation of these measures were elaborated at the National Level. Level and International Level. addition, a strategy for a Plan Action for eradication of illiteracy (1990-2000) was also suggested.

The new strategies being adopted in our country under the National Literacy Mission which aims at imparting functional literacy to 80 mil-

lion adult illiterates in 15-35 agegroup are as follows:

- (i) Design motivation centred programmes.
- \approx (ii) Secure people's participation.
- (iii) Significantly increase involvement of Voluntary Agencies.
- (iv) Substantially improve ongoing programmes.
- (v) Launch Mass Movement involving educational institutions, disciplined forces and their welfare organisations.
- (vi) Institutionalize continuing education through Jana Shikshan Nilyams.
- (vii) Ensure availability of standard learning material.
 - (viii) Universalize the outreach.
- (ix) Undertake Technology Demonstration in 40 districts for development, transfer and application of techno-pedagogic inputs
- (x) Establish Mission Management System at different levels.
