THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) and (b) Government is aware that the present domestic availability of plastic raw materilsis not adopate to meet the indigenous demand in full and situation of shortages will continue for some years. The projectgaps between demand and domestic availability of plastic raw materials during the current financial year and as in 1994-95 are as follows:—
