SHRI V. GOPALSAMY: Only one minute, Madam. Therefore, Madam, I would like to request the Government through you to reconsider the decision which has already been taken and annex this line with the Madurai Division. Even though the Government claims that it has opened a new line, this ig only a small project between Karur and Dindigul. What about the line from Dindigul to Madurai? Nothing has been done. ... (Interruptions)...

THE DEPUTY CHAIRMAN: All right. Please sit down. Now, Mr. Kulkarni.

SHRI V. GOPALSAMY. What about the line from Madurai to Maniyachi? Nothing has been done. They only want to hoodwink the people of Tamil Nadu an^ it is only for some political purpose that they have gone to inaugurate the function there as if they have done something great for the people of Tamil Nadu. After eight year_s they have constructed a small project to be opened by the Prime Minister!

Appeal by the Government of Kerala in a Newspaper Abroad for Donations for the Relief of Victims of the Railway Accident near Quilon

SHRI A. G. KULKARNI (Mahara-shrta): Madam, I thank you very much for permitting me to make a Special Mention which is in connection with a statement and an appeal issued by Mr. E. K. Nayanar, the Chief Minister of Kerala.

Madam, the purpose of the appeal is to help the victims of the tragedy, the railway accident, and there is no dispute about it. But the problem is that it is detrimental to the Centre-State relations, particularly when our friends in the Opposition complain about the Government not following the recommendations of the Sarkaria

Commission. Madam, for your information, I quote only two paragraphs. According to Mr. Oome_n Chandy who is the Deputy Leader of the Con. gress I Legislature Party:

"Moreover, the appeal said that money was required to ensure the 'safety' of the rail travel in the

I d_0 not understand when Mr. Nayanar thought that Kerala is not a part of India? Is it not a part of the Railway Ministry of the Government of India which looks after all these difficulties? It does not become a Chief Minister to make such an appeal to the Gulf workers. Many Keralites are working there.

Second, there is also another very important point highlighted by Karunakaran, leader of the Congress party in the Keral Legislature. He wondered if the necessary clearance of the Union Home Ministry had been obtained for collecting funds from a foreign country and other rules had been observed. Madam, they have also given certain telephone numbers of the Gulf merchants and the money has to be sent to the Commissioner and Secretary. Finance Department, Government Secretariat. This is totally flouting the RBI regulations about the receipt of foreign money. It is the Home Ministry which has to give permission to any State Government o_r any organisation to bring in foreign funds. Mr. Karunakaran further stated, Madam—I quote, again:

"It had to be made clear whether the agents in Kuwait whose telephone numbers were given could collect them on behalf of the Government."

This is one question.

Then, Madam, one Mr, Aryada a Mohammed, MLA, who was present at the press conference, pointed out that under Section 4 of the Foreign Contributions Regulation Act, members of State legislatures and the

I am sorry that the Kerala Chief Minister, without consulting the Government of India either in the Finance Ministry or in the Home Ministry or the Reserve Bank of India, issued such an appeal which was published by way of an advertisement in the 'Kuwait Times' of the 3rd August. This appeal was made for -raising donations from those people who were living in foreign countries

for assisting the victims of the railway tragedy. Madam, under the rules, without the prior approval of the Home Ministry, not even a charitable instituion can raise foreign funds hke this. No one can raise these foreign funds under the rules. Shortcircuiting the whole procedure, the Chief Minister issued this appeal which, in my humble opinion, has lowered the prestige of the country in the eyes of the foreign people. From that advertisement, they might have come to the conclusion that the Government of India or the people of India are not competent or able to render assistance to the victims tragedy. Madam. Rs. 30 lakhs have already the Prime Minister for been released by be given to the victims. Rs. 1 assistance to lakh per victim have already been' promised or assured by the Railway Minister. The Kerala Government has given just a paltry sum of Rs. 5000/. to each victim. So, much more has been done by the Centre. Now, they have issued an appeal for raising donations in a foreign country and in a foreign newspaper. Madam, through you, I request the Government of India to make a thorough probe into this matter and to obtain the necessary explanation from the Chief Minister of Kerala for the irregularity mitted by him. It must also 'be found out ho-w much money has been collected and by Madam, it should be ensured that such incidents don't occur in future.
