

Long Term Promotion As ad-hoc , Promotion

4301. SHRI TRIDIB CHAUDHURI : Will the PRIME MINISTER be pleased to state:

(a) whether long term promotion has been treated as ad-hoc promotion for the purpose of option in pay fixation on promotion in terms of Department of Personnel and AR. O.M.No. 7/1/80-Estt. Pl, dated the 26th September, 1981 read with their O.M. No. 13/28/82-Estt. P.I, dated the 8th February, 1983;

(b) if so, the reasons for which Assistants/Stenographers Grade-C who have been promoted on long term basis (which is actually ad hoc promotion), have been allowed to appear in S. Os/Stenographers, Grade 'B' Limited Departmental Competitive Examinations, for which only Assistants/Stenographers Grade-C with five years, regular/temporary services are eligible;

(c) what are the reasons for which those persons, who have been appointed/promoted on adhoc basis and subsequently appointed on long term basis (which is also ad-hoc) are still continuing and have not so far been made regular (Select List promotees) in spite of instructions issued by the Department of Personnel and Training in their O.M. No. 28036/8/87 Estt(D) dated the 30th March, 1988; so that they may get benefit of the aforesaid option; and

(d) what action Government propose to take in the matter and upto which time these persons are likely to be made regular (Select List promotees)?

(a) Yes, Sir.

(b) The CSS Rules, 1962 provide for counting Long term officiation period as approved service for determining the eligibility criteria for Limited Departmental Examinations.

(c) and (d) O.M. No. 28036/8/87-Estt. (D) dated 30-3-1988 provides only the guidelines for identifying the ad-hoc vacancies and the mode of filling up of such vacancies.

Inclusion of long terra appointees in the Select Lists are made depending upon the availability of such vacancies in different cadres from time to time.
