Maharashtra-Karnataka Border Disputes

844. SHRI PRAMOD MAHAJAN: Will the Minister of HOME AFFAIRS be pleased to state;

(a) what steps have been taken by the Central Government during the last three years to solve the longstanding border dispute between Maharashtra and Karnataka; and

(b) what is Central Government's reaction to the recent suggestion made by the Chief Minister of Maharashtra to resolve the issue by referendum in the disputed border areas?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SANTOSH MOHAN DEV): (a) and (b) The Government of India have always been of the view that this dispute can be resolved only with the willing cooperation of the State Governments concerned. The Central Government remain in touch with both the State Governments in the matter Central assistance as required for arriving at a mutually acceptable solution to this problem will be rendered.

Setting up of a Jewellery Export Centre at Ahmedabad
