Accordingly, Government of Arunachal Pradesh has been informed and advised on 1-11-2006 to make alternative arrangements at their end.

#### Life insurance to soldiers

 $\dagger$ 2300. SHRI MOTILAL VORA: Will the Minister of DEFENCE be pleased to state:

- (a) whether Government are considering to provide the facility of life insurance to all the soldiers;
  - (b) if so, the details thereof; and
  - (c) by when this facility would be available for the soldiers?

THE MINISTER OF DEFENCE (SHRI A. K.ANTONY): (a) to (c) The Army already has an Insurance Scheme which provides life insurance cover to Defence Service personnel including soldiers on payment of a monthly subscription. The said Scheme also provides extended insurance cover to ExServicemen upto 25 years after retirement or 75 years of age whichever is earlier on payment of one time non-refundable premium.

## Encroachment on civilian land by army in Arunachal Pradesh

- 2301. SHRI NABAM REBIA: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is a fact that the army has encroached upon the civilian land in Sing Chung village under west Kamung district of Arunachal Pradesh;

THE MINISTER OF DEFENCE (SHRI A. K. ANTONY): (a) to (d) The army is in occupation of 115.19 acres of land in Sing Chung village. Ajoint military civilian survey by a Board of Officers to resolve land encroachment issues was carried out in May, 2003. Formal acquisition of land has not yet been completed. Therefore, the question of benefits being given to land donors does not arise.

## Military exercise between India and US
