

The New Line and Gauge Conversion projects could not be taken up mainly due to constraint of resources and heavy commitments already on hand. The suggested doublings have not been taken up so far so as to use the available resources for doubling of more critical freight-intensive sections.

Assault on the Principal of Kendriya Vidyalaya, Rewari

990. SHRIMATI BIJOYA CHAKRAVARTY: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) whether any incident of physical assault on the Principal of Kendriya Vidyalaya, Rewari by some teachers of that Vidyalaya in April, 1988, has come to Government's notice;

(b) if so, what are the details thereof;

(c) what are the findings of the investigations, if any;

(d) whether it is a fact that the victim has been transferred; and

(e) if so, what are the reasons therefor?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) and (b) Yes, Sir. A complaint was received from the Principal that some teachers of the Vidyalaya assaulted him on 29-4-1988 in his office.

(c) A preliminary enquiry was conducted by the Kendriya Vidyalaya Sangathan. Enquiry was also conducted by the Police on the report lodged with them by the Principal, Kendriya Vidyalaya, Rewari. The preliminary enquiry conducted by the Kendriya Vidyalaya Sangathan revealed that the Principal was assaulted by some teacher. However, the enquiry conducted by the Police could not establish the charge.

(d) and (e) Yes, Sir. The Principal has been transferred because he himself did not want to continue in the Vidyalaya.

Setting up of a Central University and IIT at Tezpur (Assam)

991. SHRIMATI BIJOYA CHAKRAVARTY: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) whether Government have decided to set up a Central University and an Indian Institute of Technology at Tezpur, on the basis of the recommendation of the Site Selection Committee set up by the Assam Government; and

(b) if so, by when the construction work for the said institution is likely to be started?

SHAHI): (a) and (b) The Indian Institute of Technology is being set up near Misa in the Naogaon District of Assam on the recommendation of the Site Selection Committee of the Central Government. As far as the proposed Central University in Assam is concerned, the details regarding the type and nature of the University, its location, etc., are being finalised. The construction work for the establishment of these institutions will start only after necessary formalities, including legislation, etc., have been completed.
