- (b) The Government of Uttar Pradesh has not setup any special police station for registering cases under SC/ST (PoA) Act.
- (c) No data regarding number of cases in which victims were given compensation by State Governments is maintained by the Central Government. However, it is a statutory obligation on the part of the State Governments/UT Administrations to provide relief and rehabilitation to the vicitms in accordance with the provisions of SC/ST (PoA) Rules, 1995.
