## Funds allocated under integrated Rural Water Supply Programme

†2403. SHRI BALAVANT ALIAS BALAPTE: SHRI SHREEGOPAL VYAS:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of amount allocated to various States during the year 2005-06 and 2006-07 under Integrated Rural Water Supply Programme;
- (b) whether it is a fact that some States have not fully utilized the said amount:
  - (c) if so, the details thereof and the reasons therefor,
- (d) whether Government have formulated any programme to accelerate the pace of the said Scheme; and
  - (e) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRIMATI SURYAKANTA PATIL): (a) to (c) Water is a State subject and as such State Governments are primarily responsible to provide drinking water to the rural habitations. To supplement the efforts of the State Government in this direction, financial assistance and technical support is rendered to the State Government through a Centrally Sponsored Scheme namely Accelerated Rural Water Supply Progamme (ARWSP). State Governments are, however, competent to plan, sanction, implement and execute rural water supply schemes for the coverage of rural habitations from funds provided under ARWSP at State level. As per the ARWSP guidelines the States are required to submit proposals for release of second instalment after having utilized 60% of their available funds by December end. Based on the past experience, it is seen that all the States are able to obtain their second instalment under ARWSP in the given financial year. The details of amount allocated to various States during the years 2005-06 and 2006-07 under ARWSP are given in Statement (See below).

(d) and (e) Drinking Water Supply is one of the six components of Bharat Nirman which has been conceived as a plan to be implemented in four years, from 2005-06 to 2008-09 for building rural infrastructure. The objective of the said component is to cover balance 55067 uncovered habitations as well as to address problem of slipped back and quality affected habitations by 2008-09.
