Employment Policy for the youth

2370. SHRI O.T. LEPCHA: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the State-wise details of unemployed youths in the rural and urban areas of the country as on 30th November, 2006;
- (b) whether Government have formulated any employment policy in the matter:
 - (c) if so, the details thereof; and
 - (d) if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI OSCAR FERNANDES): (a) Reliable estimates of employment and unemployment are obtained through quinquennial National Sample Surveys carried out by the National Sample Survey Organisation (NSSO). Last such survey, for which results have been published, relates to the year 2004-05. State-wise estimate of unemployment rates for youth (15 to 29 years) as per usual status approach are given in the Statement.

(b) to (d) The generation of employment was viewed as a part of the process of development and not as a confict with, or to be pursued independently of economic development. Planning process, therefore, made no attempt to have an independent employment policy.
