Emergency Response Committee has been set up by the Department of Atomic Energy to deal with emergency situations in the nuclear installations. This Committee ensures that emergency procedures and action plans are prepared by the State concerned in consultation with the Nuclear Installation Authorities to safeguard the public in the event of an emergency Occurring in any of the nuclear installations. Such plans have been prepared in .respect of the nuclear power stations at Tarapur, Rajasthan, Kal-pakkam and also for the Narora Atomic Power Project under construction. In order to test the emergenry preparedness, regular dribs are carried out. Two emergency "Off-Site" exercise in the public domain have been conducted, one at Kalpakkam and the other at Rajasthan.
