## Delay in Completion of the Irrigation Projects of M.P.

THE MINISTER OF STATE IN THE MINISTRY OF WATER RE. SOURCES (SHRIMATI KRISHNA SAHI): (a) and (b) The main reasons for delay include financial cons-trants, cost escalation, inadequate investigations at the project formulation stage, difficulties in land acquisition and nonavailability of forest land and building materials at times. These have been resulting in overall cost escalation of projects.

(c) The State Governments have been advised to priorities the projects for optimal allocation of available resources and lay stress on completion of ongoing projects.

(d) The commissioning of Sindh Phase-I and Rangwan HLC have been delayed by about six years due to financial constraints, non-transfer of forest land to the Irrigation Department, as also change in the scope of the project.

## **Gold Deposits of Goans In Portugese Bank**

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH); (a) and (b) A large number of persons in Goa had deposited gold ornaments as security for loans with the Portuguese Bank (Banco Nacional Ultra Marino). The question of return of these ornaments and other securities has been taken up with the Portuguese Government through diplomatic channels. An official indication about the return of these ornaments and securitieg is awaited from the Portuguese side.

(c) and (d) While information about the total number of families is not available, it is estimated that loans advanced against these ornaments relate to 6531 accounts. The question of return of the gold to tha families is dependent upon the decision of the Portuguese Government.
